On July 17, 2025, I spoke with a female identified as Jerri Toms regarding a harassment complaint. Mrs. Toms stated that she serves as the secretary for the Homeowners Association (HOA) at Lake Park.

According to Mrs. Toms, there have been ongoing issues involving several board members who have failed to pay their dues. She reported that the matter was taken to court in May of this year, where Judge Thurman appointed a Special Master to oversee the case. Mrs. Toms noted that board member Anna Jackson was particularly upset about the appointment, as it resulted in an increase in her HOA dues.

Mrs. Toms further reported that on Wednesday, July 16, 2025, she received a text message from Mrs. Jackson requesting to meet with her to "settle the situation once and for all." Ms. Toms perceived this message as potentially threatening, which prompted her to report the incident.

Debbie Hilton owns a home on Tresa Street, located toward the middle of the neighborhood. The roads near her home include large rocks, dirt patches, massive puddles and deep gorges.

"Not too many people live out here because, I believe, of the roads," Hilton said.

The roads are prone to flooding when it rains, which can cause Hilton to miss church. She has even missed a few days of work due

"I'm hoping that these roads can be fixed properly so mail can get back in here," Hilton said.

Around 90 people own property in Lake Park, including Anthony Johnson. He has lived in Lake Park since 1999 and said that the roads are the worst they've ever been.

"They're barely roads at this point," Johnson said. "I'm ashamed to tell people I live in Lake Park because it's just gone downhill."


