RE: Belcher v Lake Park Resort, Inc.

In order to facilitate a legal and uneventful board election, the following is required from plaintiffs:

1. **Eligibility:** An accounting of all member dues collected from your office and dates received in order to update financial records and determine member eligibility.
 - a. As the sitting officers, **we** will incorporate these records into the existing database, compiling a MIGS mailing list for election notifications, nominations, and official ballots.
 - b. Note that the 2023-24 fiscal year has now ended, and 2024-25 dues are now payable.
 - c. Dues for 2023-24 and 2024-25 must be current **prior** to the election date.
2. **Nominations:** Present a list of **plaintiff** nominations, consisting of a name and which office they are seeking:
 - a. Members may nominate themselves.
 - b. Must be Members in Good Standing (MIGS) **prior** to election date **TBD**. (Refer to Item #1)
 - c. Including the five incumbent officers at the time of this letter, there are 32 MIGS (excluding dues currently being held in escrow at your office. (See Item 1)
 - d. All nominees will be listed on mail-in ballots.
3. **Location:** We've used the public library's conference room for the past two years as it offers comfort and shelter in the event of inclement weather and has a professional atmosphere.
 - a. Date needs **TBD** ASAP in order to reserve the room.
 - b. If any resident needs transportation, we can arrange a rideshare.
 - c. If Zoom is to be offered, it will be for spectators only.
 - d. We can offer it through the existing website.
4. **Dates:** Allowances need to be made for the mailing and return of the notices below, as well as ballots.
5. **Notices:** Notices need to be written and mailed to ALL property owners by **presiding** officers, NOT the plaintiffs. Until the election takes place, this incumbent board is responsible for corresponding with the membership as a whole, with the exception of *campaign literature.

These notices include:

 - a. A notice to the owners informing them of the 2-year amnesty on arrearages, as was allowed for plaintiffs, including a *deadline* **TBD** for receiving any such dues and/or nominations back at either of the two specified locations.
 - b. Nominations may consist of plaintiffs, incumbents, and/or any MIGS who wishes to volunteer their time. Nominees may declare for one office only.
 - c. A second notice containing registered mail-in ballots, with a return deadline of **TBD**.
6. **Ballots:** **All** ballots will be mailed via USPS.
 - a. One ballot per household will be mailed.
 - b. Only those members listed in good standing from item No. 1 will receive a ballot.
 - c. Ballots will arrive pre-printed with owner's name and return address, as well as a unique registration number for validation.
 - d. Ballots will be in the form of a postage-paid 4x6 postcard. (Sample included)

7. **Voting:** Votes will be cast by returning the postage-paid ballot to the pre-addressed location, which will be the law offices of McClanahan & Winston, the receipt of which will be logged and remain in safe keeping until the certification meeting.
 - a. The return address location was chosen because their mail service provides a permanent record of all incoming mail.
 - b. Ballots and mail log shall remain **in the attorney's** custody until the certification meeting date **TBD**.
 - c. Each vote cast will be counted and **recorded** by the representatives established by the respective parties, those being **Anthony Johnson** and **Grant Billings**.
 - d. Under the supervision of C. Douglas Fields and Matthew McClanahan, the election results will be certified.
8. **Records:** Possession of all past & current files, records, and keys will then be transferred to the incoming board secretary for **safekeeping**, according to the certified voting outcome.
