Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of these Terms and Conditions:

Officers means an entity that controls, is controlled by or is under common control with a Board, where "control" means ownership of 51% or more of the shares, equity interest, or other securities entitled to vote for election of directors or other managing authority.

Country refers to: Tennessee, United States
