I almost do not feel safe to go out to my property, and have even talked with my wife, Luna, about selling it due to this whole lawsuit matter. The defense has provided everything asked for while the plaintiffs have done nothing but change the rules and issue threats. Mr. Fields has telephoned me, harassed me for sensitive member information, and has called every play unchecked. Our attorney has allowed this to continue by not acting swiftly in our interests and has neglected, over and over again for 2 years, to get Plaintiff's response to our discovery and documents requests. In my humble opinion, BOTH attorneys deserve some form of censure.
